Origin of the personal	We process personal data that we receive or have received from you as part of the
data	application or selection process.
	As a rule, personal data is collected directly in the selection process for the position to be filled. In addition, we may process personal data that we have permissibly obtained from publicly available sources (e.g., professional networks).
Categories of personal	We process the following categories of personal data about you.
data	 <u>Identification data e.g.</u> name, date of birth, place of birth, gender, marital status, names and dates of birth of family members, photo <u>Private address and contact data, if applicable with marital status and relatives</u> <u>Development/appraisal data e.g.</u> CV, references, qualifications, evaluations,
Purposes and legal bases for the processing of personal data	We process your personal data primarily based on Art. 6 (1) b GDPR. According to this, the processing of data is permitted if it serves the purpose of <u>establishing</u> , <u>implementing</u> <u>and terminating the employment relationship</u> .
	In addition, we process personal data in accordance with Art. $6(1)$ c GDPR in conjunction with local law, insofar as this is necessary for the <u>fulfillment of legal obligations to</u> which we are subject as a company. The purposes of processing include, for example, retention obligations under commercial and tax law, or social security law.
	In addition, we are required by European anti-terrorism regulations 2580/2001 and 881/2002 to check your applicant data against so-called "EU terror lists" at the latest prior to any intended recruitment to ensure that no funds or other economic resources are provided for terrorist purposes.

	If claims are asserted against us, the time for which personal data may be retained may be extended.
	If we would like to store your application (your personal data) to be able to return to it for another vacant position in our company, we will contact you separately in writing and ask for your consent in this regard.
Data subject rights and right of appeal	In accordance with Art. 15 GDPR, you have the right to receive <u>information</u> about the data stored about you. If incorrect personal data has been processed, you have the right to <u>rectification</u> in accordance with Art. 16 GDPR.
	If the legal requirements are met, you may request erasure pursuant to Art. 17 GDPR or <u>restriction</u> of processing pursuant to Art. 18 GDPR.
	According to Art. 20 GDPR, you can assert the right to data <u>portability for data that is</u> processed automatically based on your consent or a contract.
	In addition, you have the right to object to data processing pursuant to Art. 21 GDPR. In this case, you have the right to object at any time, on grounds relating to your situation, to the processing of personal data concerning you that is carried out based on Art. 6 (1) f GDPR (data processing based on a balance of interests).
	If you object, we will no longer process your personal data unless there are compelling legitimate grounds for the processing which override your interests, rights and freedoms, or the processing serves to assert, exercise or defend legal claims.
